Leah Dalton – Expressed concerns with divided country, losing freedoms, vaccines, testing. Concerns with not being informed about what was presented to children without parent consent.

Community Member – Expressed concerns with not being able to hear what board members are saying. Schools need to teach what to think not how to think.

Don Lockhart – Expressed concern about mask mandate and not being able to hear board members speak. Concerned about mental health presentation that was presented to students. Wondered what happens if our district chooses not to comply with mask mandate.

Cheri Garron – Questioned if ICHD could or could not mandate masks. Not mandated in Livingston County requests we share publics concerns about mandates with ICHD. Allow parents to come to presentations if mental health is being discussed with students. Asked if there is an appeal process for the mask mandate.

Heather Powers – Expressed frustration with board not communicating with parents. Concerned with teachers not being held accountable to same standards as students.

Debbie Fendelet – Expressed that students are confused about the mask mandate and mitigation strategies. Feels we need more rules to get things under control.

Lori Zick – Upset that district allowed ICHD to have vaccine clinic in school. Offended about conspiracy theorist label.
