We are continuing to work on the 25/26 school year calendar and will be sharing it with the union tomorrow. The Governor's proposal came out and is more favorable than predicted. It includes a recommended 4.1% increase in foundation, 31aa funds (school safety/mental health), \$125mil CTE, \$41.6 million vocational education, free student meals and \$104 million for mental health. It may come out a little later than normal this year. Beyond Basics will be finished at the end of this summer. Rachel Jones will be retiring this week. Dr. Krisan Fedokovitz has submitted her resignation. The ISD will be filling that position.
